The public policy component of the Advocacy Program is comprised of NH Lakes staff and volunteers participating in various councils, committees, boards and commissions established in New Hampshire for the purpose of developing, reviewing and implementing public policies, statutory rules and ensuring programmatic efficacy. B. Partnership Development is one of the primary means by which NH Lakes involves and represents the hundreds of local lake, pond or watershed associations throughout New Hampshire which are the local partners through which NH Lakes achieves its mission. C. Lobbying is that component of NH lakes work that is performed when advocacy is warranted on specific legislation and may be in the form of grassroots lobbying. See Schedule O.

4b (Code:) (Expenses \$ 443,154 including grants of \$) (Revenue \$ 498,642) The Lake Host Program is an educational and courtesy boat inspection program administered by NH Lakes in cooperation with local participating groups to prevent the introduction and spread of aquatic nuisance species from waterbody to waterbody. NH Lakes secures grants to hire and provide payroll and payroll services for approximately 285 seasonal employees (and 507 volunteers) working as Lake Hosts with local sponsoring groups (lake associations, municipalities) at approximately 100 public boat ramps. Local sponsoring groups are required to match the payroll amount provided by NH Lakes at a minimum of 100% either through in-kind volunteering or by contributing cash to the program which NH Lakes allocates towards local Lake Host payroll. During the summer of 2015, Lake Host staff and volunteers inspected over 92,000 boats and discovered and removed 48 plant fragments of invasive species. (The net gain shown for this program reflects allowable overhead that was not picked up in the tax return.)

4c (Code:) (Expenses \$ 26,544 including grants of \$) (Revenue \$ 18,869) Summer Youth Employment Program Purpose: An education and employment program that engages financially disadvantaged and academically at-risk high school students in Lake Hosting and Lake Conservation Corps projects. Youth also engage in other outreach activities that encourage lake and watershed stewardship on the local level and provides interactive curriculum instruction and transportation services.
